- The title in the Products and other rights and interest in the Products shall directly pass on to the Direct sellers from Enroots Horizon Pvt. Ltd. company. The risk or loss After delivery of goods/Product and after full payment of the Product will be borne by the Direct seller.
- Before accepting delivery of any Product, the Customer / Direct seller shall reasonably ensure that the Product's packaging is good condition and is not damaged or tampered.

Governing Law

- Any dispute in between Direct seller or nominee of DSA and Enroots Horizon Pvt. Ltd. company, arising on any issue by this policy, shall be referred to the sole arbitrator (appointed by the company) and same shall be adjudicated by such Arbitrator as per provisions of Arbitration Conciliation Act, 1996. However, all proceedings shall come within the jurisdiction of Alwar Courts (RAJASTHAN, India) only and such arbitration proceedings shall be held in District courts of Alwar (RAJASTHAN, India) only.
- The final decision of the Arbitrator would be binding upon both the parties. Any breach of this covenant by the Customer / Direct seller will make him liable for damages and legal costs to the Company.
